**Abbey Reaches Out**

**Pilgram Center Opens It's Doors**

The Saint Leo Abbey, in conjunction with several lay people from the area, has established a center of faith renewal that is available to all people. The project was named the "Pilgrim Center" on the assumption that all are pilgrims, walking the road of life, in search of the primary values of God, self-awareness, and an awareness of others. The center is located near the Abbey Church - Carmel Hall area of the campus.

The director of the Pilgrim Center, Mr. Peter Carney, was asked to explain some of the Pilgrim Center philosophy. Carney stated, "The purpose of the Pilgrim Center operation is basically to provide on opportunity for people of different age levels to spend some time away from their normal, everyday life, to figure out what role, if any, God plays in their life."

The center books groups of different sizes to come there and stay one day, two days, a weekend or an entire week. It provides for flexible arrangements to fit the needs of the specific group. The old Wilson House, now the Pilgrim House, accommodates mostly youth groups. It has a maximum capacity of 40. Rooms in two floors of Saint Leo Hall have also been facilitated for adult groups who come to the Center. The groups have access to the Abbey Church, the Pilgrim Card Shop, Abbey Golf Course and Clubhouse, swimming pool, bowling alleys, grotto and all

recreational facilities of Saint Leo College. The cost for each "pilgrimage" is quoted to each group, depending on the size and circumstances of each group.

Programs are available for youth groups, professional people, students, military, married couples, elderly, teachers and a wide variety of others. (During the interview, a group of Lutheran ministers were on a "pilgrimage" at the center.) A group of 150, from different religions, will be coming down from Chicago soon. None of the programs are developed exclusively for Catholics.

The center has a paid professional staff of eight. When the program gets into full swing, there will be a volunteer staff of 40, who will be leaders in the different programs.

The Pilgrim Center idea was started in September by the Abbey. It was felt that the grounds of this area are conducive to meditation and relaxation. Mr. Carney explained the careful planning that went into the center, "We wanted to research our philosophy before we started teaching it to others."

The center will probe into the different areas of life. For example, one "pilgrimage" will discuss the topic of death. Carney explains, "We're reaching out into areas into which the traditional Catholic Church has never looked."

About the financial aspects of the center, Carney stated, "We intend for it to be a profit making operation." He sees the possibility of the center making \$10,000

profit over a given year. The profit will be put back into the program, through the renovation of the grounds and buildings. The possibility of putting an elevator in Saint Leo Hall, aiding the elderly "pilgrims" was also discussed.

Carney mentioned the aspect of publicity. "We have not really begun any external publicity." He said he felt that the people of Saint Leo should be the first to know about the program.

**SHAW DENIES RUMORS**

The Monarch asked the Dean of Men, Mr. Paul Shaw, to comment last week on rumors that his job may be phased out, as part of a budgetary cut next year, with most of his duties being shifted to the Vice President of Student Affairs. Shaw said that he had never been told about this by anyone. Shaw went on to say, "things are tight" but, "I expect to work here next year." Later, Shaw said he had no concerns about his job because, as he put it, "Louie O'Gorman (Vice President of Student Affairs) and I are good friends." Dr. Southard said that there were no plans for eliminating the Dean of Men position, however, he did leave open the possibility of the move as an "emergency measure."

**Cafeteria Denies Any Trouble With Help**

The manager of the McDonald Center cafeteria, Glenn Consagra, denied that he was having any trouble with the employees at the cafeteria, despite reports by several employees to the contrary. One employee, who will go unmentioned, said that at one point last week "all of us were going to quit." She went on to say that she will probably be leaving in the near future, partly because she feels students aren't being served what they were three weeks ago when the cafeteria was under different management. Another employee said he felt Consagra had poor relations with his employees because he is "too business-like" and spends most of his time away from employees, in his office.

When MONARCH asked Consagra to comment on these allegations, he said that he has changed the procedure very little

from what the previous manager had done. He did, however, say that he had changed the portions students receive of french fries, saying they were getting very expensive.

Consagra commented on his standing with his employees, saying "I don't have any trouble with employees." He went on further to say, "I have no unhappy employees." He said that one cook, who had been here for six years, quit "to take on a better job. She said it had no bearing on us." Consagra is currently looking for another cook to take her place. One employee reported that the assistant manager, Bob Woodard, had to "beg" another cook to stay.

Consagra later said that if he did have any unhappy employees, he wishes they would come in to see him.

**Scholarships Available**

There are scholarships available to certain students at Saint Leo. Here is an overview of those opportunities and, for more information, one must contact the respective departments listed in this article.

The department of academic affairs has grants for partial tuition to students "earning the highest GPA as of the end of the previous January semester." This scholarship is entirely granted according to academic achievement at Saint Leo and is only available to full time students who have completed all of their college work at Saint Leo.

A Presidential Grant-In-Aid is a gift available to students who "evidence exceptional and superior qualifications and who render a genuine service to the college." These gifts go toward tuition. Applications for a Presidential Grant-In-Aid are made directly to Dr. Southard.

Athletic and music scholarships are available to students who are talented in these fields. Information on these can be sought by

contacting the acting divisional chairperson in fine arts, Dr. Larry Sledge, and Mr. Norm Kaye of Physical Education.

Two scholarships are also available to residents of the Saint Leo - Pasco County area. The Saint Leo Women's Club gives an amount of money which is determined yearly to a student from the area (whose family also resides in Pasco County). The student must maintain a 2.0 average and demonstrate financial need.

Tri-County grants are available to students with determined need (PCS) who are permanent bona fide residents of Pasco, Hernando or Citrus Counties. To be available for these, the student must have resided in the county one year prior to attending Saint Leo. Other gifts are available in Pasco County. To research this, students are advised to contact community groups and their Chamber of Commerce to seek information on available programs. Immediate action is urged, as deadlines for grants for next year are usually in March or April.

### Who's Graduation Is It Any Way ?

Every year as the second semester gets underway, the seniors begin to think of graduating. Along with these thoughts, visions of the final event become more real. At Saint Leo, graduation day is an affair given over to the careful planning of the college's Public Relations Department. The seniors for whom the graduation is ostensibly being held are asked for their suggestions as to whom they want for a commencement speaker. End of role in graduation day planning. But, as was noted, these are only suggestions and carry less weight each year. Last year, for instance, the commencement speaker, Chesterfield Smith, then President of the American Bar Association, even though a notable personage, was scheduled in the middle of the first semester without the benefit of prior consultation with those who were to graduate.

It seems as though there is a considerable degree of planning given to things that some people would otherwise consider optional, such as announcements, invitations, cards and caps and gowns. Yet there is no consideration of things that the people graduating do want, such as Senior Week. Senior Week costs about \$1,200 and provides the graduates and their parents with an opportunity to have a good time together before departing Saint Leo. For the student, it is a chance to say thank you to his parents. Should it be of any less importance to the administration to say "thank you" to the people who have paid the lion's share of the college's operating costs?

Even though there is all this planning for things the students don't necessarily want, all are obliged to pay the \$45 fee before their account is cleared and diploma released. And yet, the seniors are told there is no money for Senior Week, the one thing they do want . . . why?

Every year the same questions are raised. Why the fee? Why no say in the planning? Why aren't seniors permitted to speak at their own graduation? Why is not the fee optional? These are some questions, there are others.

Many answers have been offered over the years to resolve the above questions, but none with as much insight as the one offered to me last week by a good friend of mine. He said, "Why are you so riled about having no control over a lousy 45 bucks, when for four years you haven't had a tinker's damn to say about how the other 12 grand was spent?" I looked at him with a blank face and said, "You know, you're right." He retorted and, with a quick smile, said "I've known for four years, you lose." A third party present asked my friend, "And you, what is it that you have won?" I saw on my friend's face the mirror image, the blank facial expression that I, only minutes ago, had had on my face.

### On Slums And Tennis Courts

Recently the Monarch has been criticized for not being a complacent, sports oriented newspaper. It has been said that the Monarch has attempted to make a social statement and that statement has often been too honest for certain members of the college community. We plead guilty to that charge.

Living at Saint Leo in the beautiful, rolling hills of Florida, one can feel a certain distance from reality. The buildings are old and hold a bright history. The grounds are well kept and it has an aura of a country club area. Tennis courts, a golf course, an olympic size pool, a gymnasium, basketball courts engulf the campus. Swaying palms dot the grassy campus, wrapped around Lake Jovita.

The life style of the students is slightly damped by the ancient dormitories, but the recreational and drinking facilities around town bring everyone out. Students are offered an extraordinary relationship with faculty on a personal level. Students often build friendships with teachers, making sure that they are not one of those marked by a budgetary cut.

Faculty enjoy the small classes and living conditions in the country. They are not at all

unified and their pay is not good, but the college offers employment and opportunity to teach at a small, liberal arts college.

The administration also has it well off at Saint Leo. Many live on college property and their salaries are better than most other positions. (in fact, the president's salary is often discussed in the local bars. From these discussions it can be assumed that his salary is somewhere between \$18,000 and 80,000 plus expenses.) They have their headaches, but generally they perform their bureaucratic duties well.

But, because Saint Leo can continue on a complacent level, should we disregard the happenings around us? Because most members of the community can continue to function, should we call this reality? But, as we continue in our Christian lives, our eyes slowly close to the effects of what we do.

But why not open our eyes? The staff of the Monarch have been accused of being too cynical in our reporting of the news. But, as we live our lives in comfort, those around us suffer unspeakable injustices.

Three members of the Monarch staff took a tour of the surrounding communities to take a few pictures. We as students

studying in a Christian college are as guilty as anyone for permitting these injustices.

Riding 100 yards in any direction during the orange season, one can find migrants working in the groves. These migrants, many of whom are employed by the Christian brothers of Saint Leo, are paid low wages and live in sub-human housing. Many of the workers are of school age and simply accompany their parents while receiving no pay.

The slums of Dade City are growing. People live in broken down buildings, old trailers and used school buses.


There are workers in the local packing plants that have lost sight of everything in life.

Yes, we at Saint Leo continue our lives with our eyes closed. All that the staff of the Monarch asks is that we at Saint Leo open our eyes to what is really happening. We are accused of just printing negative stories, but that isn't the truth. We simply offer a point of view that might not otherwise be presented. Contrary to popular opinion, everything is not rosy. The first step toward solving the problems of our world is recognizing what those problems are.

# Shaw Blasts Monarch

Dear Editor:

I have given much thought and consideration to an article in the February 6, Volume 3, Number 16 edition of the Monarch, and as Dean of Men, I feel compelled to voice my convictions on this matter. This letter is in reference to the six Saint Leo College students who were arrested at the Orange Valley Mobile Home Park.

I know these students personally and am quite disappointed in them. However, I realize that they have only been formally charged, and not convicted. I am not condoning their action or prejudging their guilt or innocence, but I am interested in seeing them receive a fair deal in the Monarch.

It should be noted that none of these students has been involved in any disciplinary action by the

College during the 1974-75 school year, and only one of these students has ever received disciplinary action. These students are actively involved on the Saint Leo campus and are a definite asset to the student body. These students are involved in such activities as collegiate soccer, intramurals, college fraternities, club football, and the residence hall staff. Even if they are found guilty of unlawful assembly, their previous record far outweighs this one mistake.

My question to the Monarch staff is, "Why have these six students been singled out and chosen to make front page headlines?" Other Saint Leo College students have been arrested and found guilty of shoplifting, assault and battery

and the passing of bad checks, yet nothing has been written about them.

I feel that these individuals have suffered enough embarrassment and have received ample publicity from the local newspapers, so why must the Monarch jump on the bandwagon? Is this the real purpose of a student newspaper? Why are certain students continually picked on? Why must the Monarch criticize fellow students? Why must there be so much negativism? I am tired of reading about the faults of Saint Leo College, the need for ecology, Town Council meetings and week old National News.

Why can't more articles be written on athletics, intramurals, organizations, individual achieve-

ments and educational ideas?

I can remember when twenty-one students were nominated for Who's Who in American Colleges and Universities. Instead of the Monarch congratulating these individuals and listing their

achievements, it chose to present a pictorial satire.

When will the Monarch decide to present some positive ideas? Its staff is quite schooled in journalism and has the intelligence to make the Monarch an outstanding publication. However, it's a shame that a few of the individuals on the staff have decided to voice their personal vendettas through the STUDENT newspaper.

# Behind The Scenes Of 'Cabaret'

The stars of a theatre production are made possible only by the accompaniment of artists in many dimensions. The long months of dedication to a finished stage production of two hours also means keeping up your grade average and sweating out your body and brains day and night in a world of fantasy and reality you have chosen to make your own for these few brief days in time.

(The Saint Leo College Theatre production of "Cabaret" is running through February 12 - 15 at 8:15 p.m.)

It's not all up front that counts. You must have hard muscles and an even temper (quickly forgiving after an explosion when everything goes wrong). **Discusses Senior Week**

**And Graduation Fee**

The Senate voted Thursday to table a request made by the senior class for \$500 for the second time. Before taking that action, however, there was much discussion of the administration's responsibility to provide for the Senior Week activities out of the \$45 graduation fee that all graduating seniors must pay in order to receive their diplomas.

It was argued that the senior class should have a hand in the planning of their own graduation. Currently the event is planned entirely through the college's public relations office.

Dr. William Reardon who has been advising seniors for the last two years on matters concerned with Senior Week, noted that this is not a new problem for seniors, but that in the past the operation of the now defunct Club '67 used to be the source of revenue for this event. But in 1972 the operation had a deficit which has just been paid off and seniors now have had to seek other means of financing. These have, for the

most part, been unsuccessful. Following continued debate on the matter, Dr. Reardon suggested that he could return with a definite figure, following the showing of "American Graffiti," the seniors' final fund raising project, and the whole matter was tabled for a third time.

The senate was also advised that the administration will pay the liability insurance on the dock and will provide for future maintenance of the dock and the area surrounding it. The senate appropriated \$100 to buy materials for initial repairs and another \$100 for the construction of barbeque pits and picnic tables at lakeside.

It was announced that the lawyer recently hired by the SGA would be getting to work on a brief this week.

Carlos Mendez reprimanded the senate for being disrespectful. Carlos, the SGA's Parliamentarian, threatened to resign if things don't change.

## Blood Bank Returns Next Week

St. Anthony's Blood Bank and Phi Theta Chi fraternity have scheduled a blood drive at Saint Leo College for February 17, 18 and 19. The drive, which is the second of the school year, will be held in Duncan Lounge.

The previous blood drive was held November 5, 6 and 7 and 179 units (pints) of blood were donated by concerned students. St. Anthony's staff and Phi Theta Chi hope to reach their goal of receiving more than 200 units of blood during the coming visit to Saint Leo. We are hoping to have faculty members and other college employees donate blood, as well as an increased number of students.

There are advantages to giving blood, other than the good feelings that result following your life-saving donation. St. Anthony's Blood Assurance Plan (B.A.P.) protects you and your

family in case a need for blood arises and it is good anywhere in the United States, its territories or Canada. Members of the B.A.P. are concerned citizens who become members of this plan by donating one acceptable unit of blood placed on deposit with St. Anthony's Blood Bank. The plan is effective for a one year period and must be renewed annually.

Consider this - if you require a blood transfusion, you will pay up to \$80 per unit unless you have credits at an accredited blood bank or unless someone donates blood in your name to replace units you have used. Most health insurance policies do not cover the cost of blood.

NATIONAL NEWS NOTES

CHILES SEEKS TO END LAME-DUCK TRAVEL

Florida's Senator, Lawton Chiles has introduced legislation to make it illegal for lame-duck congresspeople to go on foreign trips, commonly referred to as junkets. It seems, according to Chiles, that every two years there is a mass exodus of congresspeople on trips abroad. The bill would make it illegal to use federal appropriations or transportation for such trips.

HOUSE VOTES TO DELAY OIL TARIFF

The House voted 309 to 114 to stop President Ford's tariff on imported oil. The House passed a bill that will suspend for 90 days the authority Ford claims to impose by Presidential order a \$3 per barrel tax on foreign oil. The \$1 per barrel tax of February 1st would also be cancelled.

ATT ASKS ANTITRUST DISMISSAL

Lawyers from American Telephone and Telegraph Company have denied antitrust charges filed by the Justice Department. ATT said the suit should be dismissed on the grounds that its alleged monopolistic practices have had court approval because of a 1956 settlement of a similar suit.

The assistant manager, Bob Woodard, feels that repetition is a problem for the students who eat in the same place every day. He

termed this as being "a boring situation," as long as girls are not in the cafeteria. Consagra interjected, saying "I'd like to have their income."

Consagra then apologized for using a tape recorder on this reporter in an earlier interview.

The president of the sophomore class had intended to petition the cafeteria because the quantity and quality of the food has dropped. The SGA convinced him to drop the idea, pending an investigation of the food service by the United States government Food and Drug Administration.

Centennial Wagon Train Takes To Road

WASHINGTON (LNS) - Imagine 13 horse-drawn covered wagons (steel reinforced à la 20th century) traveling throughout the country for one year to celebrate the 1976 bicentennial - all to the tune of \$5 million, 10,000 horses and 5,000 volunteers.

If you're not crazy about the idea, it's understandable, what with the economy as shaky as it is. But the American Revolution Bicentennial Administration (ARBA), the U.S. government agency in charge of all 1976 festivities, is all out for it, so it looks like the "Bicentennial Wagon Train Pilgrimage" will soon be a reality. What's more, it's likely to be THE major national commemoration of 1976.

EARLY HISTORY OF OUR

"But it's more than just fun and games," says T. Gray Associates, which has been paid \$100,000 so far by Pennsylvania and is negotiating a contract for another \$180,000. "It's the kind of adventure where the nation can search for, and probably find, some of its lost integrity."

T. Gray Associates is negotiating with several large corporations, including Ralston-Purina, General Motors and AT&T, to underwrite the cost of the wagons, horses, food for horses, and staff, uniforms, vehicles to carry equipment, barges to carry the wagons down rivers, and hundreds of incidentals.

Although the companies haven't given their full support to the plan so far, a GM spokesman

said he was "pretty positive" the company would at least provide 60 to 75 free stationwagons as support vehicles.

Some Bicentennial Commission spokespeople from other states

have grumbled about the Pilgrimage as a "poor use of funds." But Jeremy Rifkin of the People's Bicentennial Commission, a group organized to counter the official government agency, is outraged by the wagon train proposal. "It's one of the best examples of corporate America piling money into projects to keep people amused, when what they need is fundamental change; to have basic economic grievances redressed by the profiteering corporations who are hurting the working man."

Early Vow Names San Antonio

In 1881, the newly established Catholic colony of San Antonio was given its name by its founder, Judge Edmund Dunne. How Judge Dunne arrived at the name San Antonio, merits being committed to print.

Edmund Dunne was a resident of New York when he was offered a judgeship in the Arizona Territory in the 1870's. At that time, Arizona was a wild, unsettled and lawless no man's land. Often the Judge had to travel through vast expanses of uninhabited land on his judicial circuit. It was during one of these trips that the Judge and two companions became lost in an area near the Mojave Desert. Having run out of water and on

foot, the trio was in considerable despair and was fast losing hope of ever getting out of their predicament. The Judge, a devout Catholic, knelt on the sand and prayed through the intercession of Saint Anthony of Padua, vowing that if they were ever saved, he would venerate Saint Anthony in a most befitting manner. With renewed confidence, the group pressed on and before nightfall, they came upon a settlement, for they had been miraculously guided in the proper direction.

Several years later, when the Judge retired from the bench, he came to Florida as a representative of the Diston Land Company. For his services to the company, he was given a township

of land for the establishment of his colony. Remembering his solemn vow on that fateful day, the Judge decided that the name of Saint Anthony should be given to his new settlement. At the time, however, there was considerable anti-Catholic sentiment in the new State of Florida. Judge Dunne, being a shrewd diplomat, thought it would be best not to exacerbate the feelings of the surrounding Protestant communities, so he wisely used the Spanish "San Antonio." This, he felt, would bother no one. (Soon after, a large group of German Catholic settlers arrived in the area. Not having the wisdom of someone like Judge Dunne in their midst, however, they blatantly named their settlement Saint Joseph.)

John and Mary's desperately needs a new name and the owners won't be satisfied with Bill and Bob's. Bob Cabot and Bill Meyer purchased the bar from Jimmy Smith, who didn't have the time to run the place. MONARCH spoke with the Youth Director, Mr. John Frank, a former editor of this paper. Frank wants to, as he put it, "Make Saint Leo a hothouse of spiritualism." He mentioned that he has spoken to 3,000 high school students about the youth programs that are held here on the weekends.

A large influx of high school students to the center could have some impact on admissions at the college. Director Carney states, "We're not in the business of getting kids up here to go to Saint Leo College." That, he feels, is the College's responsibility. Carney did say, however, that he would direct the student to admissions if the student showed a direct interest in attending the College.

Frank said that the nucleus of the youth pilgrimages is to get young people to "come and

share" themselves. The youngsters will participate in group encounters, but it will be nothing heavy, psychologically. Frank feels "everyone has some sense of God" and the Pilgrims will share with others how to best approach Him. The youth pilgrimages are carefully scheduled through the local school, church or civic organization. The center does not provide for transportation. Youth pilgrimage activities include bar-b-que, group dynamics, a talk by a staff member, open discussion, Bible vigil, prayer, free time, group sharing, recreation, cleanup, personal writings, meditation, music. Stations of the Cross at the Grotto and a bonfire prayer service. The young peoples' pilgrimage much resembles that of summer camp—with religion.

Frank discussed having the student leaders of Saint Leo participating in a weekend pilgrimage, thus possibly stimulating widespread interest among the student body.

The Pilgrim Center has an open door policy and students are encouraged to explore the possibilities of the Pilgrim Center in their life.


