# Student Forum Today With Administration

## BURGESS RESIGNS

The Independent Monarch learned Wednesday afternoon that Special Education instructor Margo Burgess is resigning her position effective immediately.

Burgess, who had been told last April by St. Leo College President Thomas B. Southard that her contract would not be renewed for the present academic year, was later re-instated after a storm of student and faculty protest.

In a letter addressed to Southard, Burgess cites among her reasons for leaving "crass indifference of a president totally incapable of communication with a professional faculty and completely indifferent to their needs." Burgess continues saying she perceives a grim and desolate future for the Division of Creative Teaching. Bright competent faculty will leave because quality teaching cannot endure an inept administration, the

abysmally low salaries, the lack of budgetary support for quality education, the persecution of the competent and the elevation of the incompetent."

Burgess indicated her new position will take her out of state and will result in a doubling of her present salary.

Burgess said she was picking up her check at 3:00, going off campus to cash it and then delivering her resignation to Southard.

"I have left detailed records of the students work thus far," Burgess said. "I don't want the kids hurt."

Burgess closes indicating that there are other resignations that will be rendered this year, "and I trust, for the sake of the College, that yours (Southard's) will be among them."

## Southard Says St. Leo To Become "Notre Dame Of The South"

Dr. Thomas B. Southard, President of St. Leo College told a luncheon of Dade City businessmen that he has plans to put the academic institution on a level of national and international acclaim.


In a luncheon held by Board of Trustee member, A.O. Keefer, also last Thursday at the Edwinola restaurant Southard described St. Leo's focus as aimed to make it "the best known college in the country in 12 years" with building a limited enrollment of national and international character.

Southard was evasive about the actual

plans and said the reason was that the program "is still being put together."

Southard and his consultant, Dr. Lynn Barry of Fort Lauderdale, said that the existing plans they intend to announce later in the year should boost the college to both national and international recognition as high as that of Notre Dame University.

The talk to the local businessmen is the fourth in a series that Southard is holding to "cultivate" understanding of the institution in various localities. Three other talks have been given in Leesburg, Brooksville and Lakeland.

## Trustee Group To Meet Here Friday

Members of the Administration, the Faculty Senate and several members of the Board of Trustees will meet Friday morning.

According to faculty and administration spokesmen, no agenda has been established. "The meeting is to enable all sides to gain a greater understanding of the issues," a faculty spokesman said.

At presstime members of the Student Senate had not been invited. According to

an administrative spokesman the meeting is not open to the college community at large.

Joy Shepard, Director of Public Information, said that Dr. Southard had no comment as to which trustees would be present at the Friday meeting. According to several different faculty sources Board Chairman Thomas A. Welstead and former Board Chairman Raleigh Greene are expected to attend.

## Trustee Statement Backs Southard ; Union Destructive

The St. Leo College Board of Trustees at their October meeting issued a "statement of policy" proclaiming "whole-hearted" support for the college president and his administration and at the same time termed the faculty's efforts toward collective bargaining "destructive".

In the resolution, received last week by the Independent Monarch, the trustees directed St. Leo College President Thomas B. Southard to "oppose unionization by every proper and legal means."

"We cannot in the faithful discharge of

our duty, permit or condone any action which disrupts the student's education and interferes with the students right to learn and achieve his or her life's goal."

Among other instructions given Southard by the board were: that he issue an explanation of the "disadvantages of collective bargaining and unionism", to the faculty, notify all employees that "under no circumstances can they be required to join or support a union to keep their job at St. Leo College", inform those that do join

a union that they will "get no advantageous or preferential treatment."

The board included one further instruction to Southard, "if anybody causes any employee trouble at his or her home or work or puts and employee under any sort of pressure to join a union, the employee need only let the college know and the college will undertake to see that this is stopped."

In closing its statement the board said it viewed the union as an "intrusion", saying

it seeks humanistic relationships rather than adversary proceedings and contract legalisms involving labor and management."

"This Board has high regard for the collegial relationships which have build the college and which have developed student faculty administration relationships which are traditions inherent in quality education institutions as Saint Leo College has grown to be," the statement said.

After the Monarch was closed down at the end of last year, some of us who were on the staff felt that although the administration did not see the need for a paper, there was a need for a free voice.

Some people would have you believe that everything at the school is fine, that it is only the radical fringe that is stirring up trouble. We do not set the teacher's salaries. In a recent SGA meeting Dennis Mullen suggested that more power be given to the school's administration. Is there anything beyond impotence?

According to all the ads on television this is the bicentennial of the United States, a celebration of freedom. The Independent Monarch is freedom. It is the freedom to think, freedom to write and freedom to dissent. The Independent Monarch is not the New York Times, but it will never be PRAVDA.

-Why do administrators make so much more than instructors, particularly why does Dr. Southard make \$40,000?

-What was the real reason Dr. Gumer was fired?

-Why does Dr. Southard and the administration stand against the faculty union?

-Why does our tuition go up every year? Is our education getting better with the increase in price?

## Basketball is Number

### One With Scholarships

The soccer team is the black sheep of the SLC athletic department. It is called a varsity team, yet it has only one player on partial scholarship. Of all the St. Leo sports, only golf surpasses it in obscurity. Over the years the soccer team has been the bright spot in our sports program with consistently good records, but instead of being the most advertised sport for that feature, the athletic director chooses to

invest his scholarship money in the basketball program, which coincidentally he coaches. Last year admittedly, the soccer team record was not great with only six wins. But that is twice the amount of games the varsity basketball team won, with all those scholarships. This is not to say that no attempt should be made to build up the basketball program, rather it would seem that some sort of equity could be reached where every team could share the benefits of scholarships. Good players cannot be expected to come to St. Leo when other schools make better offers including better academic rating and nearness to large cities.

Another problem is that the soccer team did not play one out of state game this season, while the basketball team will be playing its very first game in Washington, D.C. It would seem logical that all the teams should have the opportunity to receive out of state exposure. If the budget only allows for a few out of state trips each year then a rotation basis should be set up so that one team could go one year and another team the next.

Other teams are suffering from this obvious discrimination including golf, tennis and all the women's sports. The football team is not included in this list because it is a club football team and not varsity.

It can be argued that to improve these sports more money would have to be spent. This is not true. Rather than spend more money,

the athletic department should spend what it has more wisely. This is not to try and tell Mr. Kaye or anyone else how to do their jobs. It is simply that if our money is being spent we should get more for it than having a bench full of basketball reserves while the other sports go begging.

It is a function for which I am singularly unqualified and in acknowledging that I feel a further responsibility to my faculty colleagues to mention that I did not seek the important task which you took it upon yourself to assign to me. I wish to clarify that less the individual faculty members with whom I have spoken now conclude that our private conversations were, in fact, interviews.

I can, however, speak authoritatively to the enjoyment I personally receive from my situation at Saint Leo College. Believing as I do that no college, no other institution for that matter, can be better than the skills and intentions of the people who serve it, I have been encouraged by the good people, students, faculty, staff and administrators, I have met here. I enjoy my work here, my present situation if you will, because through it I have been able to share myself with good people who hold a deep and sincere commitment to their roles and this place. From these people I have received the challenges and

# Dade City Police Arrest A Good Samaritan

On Saturday night Nov. 15, Bob Lennox, a student at St. Leo College did his good deed for the day; it might be the last he does for some time.


It was late Saturday night when Bob and some friends were driving up Clinton Avenue toward Dade City when they came upon an overturned Volkswagen Van. Bob immediately pulled off the road and ran to the van to see if anyone was inside. They could see someone inside and decided to act.

Bob ran to a nearby house and asked the residents to call the police. He then ran back to the van and helped his friends kick in the windshield and pull out the victim. They pulled the man out and laid him carefully about ten feet from the van. The police still did not arrive, so Bob ran back to the house and asked the people to please call again. It was about five minutes before the St. Leo Police arrived along with two rescue units from Dade City.

The Rescue Units took the accident victim to Community General hospital in Dade City while Bob stayed behind to help the police fill out the accident report. After doing so he drove to the hospital to see how the victim was doing.

When Bob arrived at the hospital he said he tried to tell the nurses what has happened to the man and that they had better not move him till a doctor came because he might have broken some bones.

The nurse reacted to Bob's advice, telling him to be quiet. He said he did not want to argue, he just wanted to warn her about the possibility of some broken ribs. The nurse apparently did not appreciate what Bob had to say, she told him to sit



down or she would have him arrested. From this point on Bob's luck took a turn for the worst.

A Dade City policeman walked into the Emergency Ward to file a report. Bob had taken a seat and was helping another nurse fill out an accident report.

The nurse Bob had had words with told

the policeman that Bob was causing trouble and if he didn't be quiet, she wanted him arrested. Bob jumped up to tell the officer that he was only trying to help the nurse, but the officer told him to sit down.

Bob told the officer that he was a student from St. Leo College and tried to explain

how he had helped the victim at the accident. According to Bob after some discussion the officer told him, "I don't want any of your wise ass shit."

Everybody told him to be quiet and sit down. He sat for awhile and then got up to get a drink of water. The police officer immediately called after Bob and asked

A second prize of \$1,000 cash and up to 10 consolation prizes of \$100 each also will be awarded. The staff and trustees of The Institute will be judges.

Deadline for entry of papers is March 1, 1976. The essay contest winners will receive their awards at a presentation ceremony in Washington, D.C. early in May, 1976. While in Washington, both the essay winner and runner-up will meet with ranking members of Congress in a symposium on welfare reform to be sponsored by The Institute or Socioeconomic Studies.

In announcing the competition, Mr. Greene said its objective is "to encourage America's students to think constructively about the vast problems caused by the failure of present U.S. socioeconomic policy."

Entrants' papers, he said, may give consideration to such topics as an evaluation of existing welfare programs,


techniques of income supplementation, and how work incentives are affected by present welfare policy and how that might be altered by adoption of an income supplement.

The Institute will have the option of publishing winning papers, Mr. Greene said. During 1975, The Institute has published two monographs, "Great Britain's Tax Credit Income Supplement", incorporating a paper by the Rt. Hon. Lord Barber, T.D., and "Social Welfare Abroad", a comparative study of the social insurance and public assistance programs of industrialized democracies throughout the world by Bette K. Fishbein, staff economist of The Institute for Socioeconomic Studies.

Currently planned for publication is an analysis by former U.S. Representative Martha W. Griffiths of Congress' next major effort to develop welfare reform legislation.

The Institute reserves the right to cancel the first and second prizes if, in the sole judgement of the judges, no suitable papers are submitted.

## Goddard Scholarship Offered

## San Antonio Candidates Are Interviewed

# Four Vie For Three Commission Seats

Four candidates are seeking election to the three San Antonio City Commission seats on the ballot for Tuesday, November 25. Francis Blornmel and Eugene Hester are seeking reelection to seats they now hold. Malin Marsh, who served for 14 years on the Commission, and Mike Alessandro, who is seeking his first term in an elected public office, are also running.

Francis Blornmel, a long-time resident of San Antonio and father of five children, is an employee of the Guide Brothers Construction firm. He believes the Commission could better serve the citizens if only the people would appear at commission meetings and voice their problems. He is particularly concerned with the well being of San Ann's elderly residents.

Mike Alessandro, 29, first moved to San

Antonio years ago with his family and returned to stay for the past 3 years. He is the Assistant Director for Law and Records at the office of the Clerk of Circuit Court in Dade City. He says he has no conflicts of interest and favors open and complete public disclosure of any political candidate's background. He sees his candidacy as an opportunity to fulfill "an obligation to serve" the interests of the people of San Antonio.

Malin Marsh, 65, has in the past served 14 years on the City Commission with two terms as mayor. He is a retired businessman who once owned the San Ann Liquors and recently operated a beverage distributorship. A commissioner's job is difficult he says, with no pay at all, but he says "San Antonio has a heart." He says "many people have asked me to run" and there are many things worth working to

preserve in San Ann. Roads, for instance, need improvement and the city needs more road repair equipment.

Eugene Hester, 62, is seeking reelection to the commission post he has held for terms totaling over 15 years. He was an employee of the Pasco County Schools for 33 years and a resident of Pasco County since 1922. He sees a need for San Antonio to expand its water resources and eventually to improve its sewage collection.

All the candidates believe that bars in San Antonio should not be forced to close at midnight. Francis Blornmel who lives near two nightspots, said he formerly favored midnight closing. He now feels that the noise problem has been reduced by the strict enforcement of the law prohibiting drinking on the outside premises of a bar. "So far, it has worked."

Blornmel also feels that the commission

should better advertise its regular and special sessions by posting notices in area stores and meeting places.

Mike Alessandro, when asked his position on a suggestion that San Antonio and St. Leo form a single municipality said, "I see good and bad things." But Francis Blornmel said "It would be a good idea" to unite the two towns, but recognized some public doubt about such an action. Malin Marsh, who noted both towns "distinct environment" opposed the suggestion unless "it's the only way to survive." Eugene Hester, who feels that San Antonio is in excellent financial condition, said he would not want to combine the towns under the present conditions of St. Leo's special relationship to St. Leo College.

## Sutton Appointed To St. Leo Town Commission

Bert Sutton was appointed by the St. Leo Town Commission at its November meeting. Sutton assumes the seat of former Town Commissioner Fr. Hugh O'Regan, O.S.B. O'REGAN forfeited his seat due to his continuing absences. Sutton had qualified earlier as a write-in candidate for the St. Leo election but as only three persons filed for the three terms expiring, no election will be held.

In other business the commission disposed of two surplus police cruisers. In sealed bidding the cars, a 1973 Dodge and a Chevrolet of the same year were sold for \$200 to Mr. Weathers of Dade City and for \$675 to E.A. Storch of San Antonio respectively.

The commission approved a motion allowing for rental of a Xerox copier. Considered also was the purchase of a tank and pump by the town for storage of gasoline. While two local wholesalers provided estimates it was decided that the matter needed further study.

The town attorney will draft an or-

danance proposing the levy of court costs in civil and criminal matters against defendants found guilty in cases heard at St. Leo Municipal Court. There are presently no court costs assessed; however if the proposed ordinance to be discussed at the Commission's December 8 meeting is approved \$2.00 would be added to fines in civil matters and \$25 in criminal matters. Town Attorney Jack McArthur indicated that these were the limits allowed by state statute, he added that this would also be another source revenue for the town.

Action on the proposed town charter was postponed until next month.

Discussion on whether the town should continue to lease the radar traffic control gun at \$50 per month or purchase the gun at a cost of \$1,385. Commissioner Sutton stated that he liked the idea of continuing to lease the gun because the town would not be responsible for maintenance of the gun. This was also the opinion of police Chief Charles Gordon.

## Pasco Has New Drug Abuse Program

Pasco Mental Health Services is currently operating an outpatient, drug-free treatment program in Dade City. This program, initiated on October 1, of this year currently has seventeen clients.

This primary focus of the program will be the treatment of polydrug abusers. Generally speaking, polydrug abusers are the individuals who abuse drugs in the barbiturate, tranquilizer, amphetamine and hallucinogen classes. Studies indicate that polydrug abuse is high among middle and upper income adult females and adolescents although this abuse prevails in other segments of society also. Many polydrug abusers also use and often become addicted to the opiate drugs which include heroin, morphine and codeine. Opiate abusers fall within the treatment capabilities of the planned outpatient program. Cases outside the scope of this program will be referred to other appropriate drug treatment centers.

The concept behind this outpatient service is to provide a therapeutic setting where clients are seen by appointment. While group counseling is available, the focus is on individualized therapy where personal, family and job-school problems can be discussed in relation to drug abuse or a return to drug abuse. For deeper, more complicated problems the present outpatient system will serve as a referral source and advocate. With the counselor's assistance, clients will be encouraged to take advantage of public and mental

health services, legal aid, vocational guidance provided by Pasco Mental Health Services and other community agencies.

The intake process for the program is structured but relatively simple. Addicted clients are referred for detoxification before acceptance into the program. Once a client is admitted, his drug and social history is compiled and a treatment plan developed. A physical examination is also part of the treatment plan.

This program is coordinated by Robert Whitford, a clinical social worker; and medical consultation is provided by Dr. D. L. Deal. All staff members are experienced mental health professionals with expertise in counseling, psychology, psychological testing and social work. Pasco Mental Health also has a consulting psychiatrist who is in Dade City on Fridays, who is available to help those in the program.

Continuous psychological and physical appraisal is considered important because sufficient information is generally not available to predict the kinds of problems which could be anticipated once drug use is eliminated for a given individual. Psychological counseling is emphasized because it has often been found to be the key to successful rehabilitation in the case of the polydrug or opiate abuser. Liaison is maintained with other facilities for detoxification in order to insure continuity of care.



Dear Dr. Southard and Members of the Board of Trustees:

I hereby summarily terminate my professional relationship with Saint Leo College and consider my contract null and void.

I joined the Division of Creative Teaching in February, 1974, at a considerably reduced salary. The once declining reputation of the Division had been transformed into one that reflected the refreshing emergence of educational innovation and academic excellence. I was eager to become a part of this team that functioned so effectively and efficiently in preparing outstanding teachers in a supportive atmosphere. This atmosphere continued until December 15, 1974, when it became apparent the administration of Saint Leo College had complete disregard for this excellent relationship which prevailed in the Division. With the unprecedented and inhumane firing of Dr. Rosanne Gmuer, which grievously intimidated the entire faculty, came the fatal blow to the team effort and cooperation in the Division. Since that time an inspired academic program put together by Dr. Gmuer and a highly professional faculty over the past three years has been demolished. The crass indifference of a president totally incapable of communication with a professional faculty and completely indifferent to their needs was central to this destruction.

I perceive a grim and desolate future for

the Division of Creative Teaching. Bright competent faculty will leave because quality teaching cannot endure an inept administration, the abysmally low salaries, the lack of budgetary support for quality education, the persecution of the competent and the elevation of the incompetent.

As a former teacher in the Pinellas County Schools, I should have predicted that you would alienate the Saint Leo College faculty just as you had the Pinellas teachers who clamored for your removal from administrative office.

I leave eagerly to take on a position in education which will pay me twice my Saint Leo salary and where my skills and enthusiasm for teaching will be appreciated. My regrets are great for those of my Saint Leo colleagues who will stay to be exploited, maligned and threatened by an oppressive, incompetent administration. Were it not for your leadership Dr. Southard, there would be no union on campus. You created the union with your threats of termination, curtailment of faculty committees and gross disregard for the basic tenets of human relations. Your vindictive battle against the faculty is foolish. I wonder at the business acumen of those members of the Board who support you so vehemently without full knowledge of the conditions that prevail at Saint Leo College.

I can assure you this will not be the last resignation that Saint Leo College receives this year and I trust, for the sake of the College, that yours will be among them.


This year's soccer team was severely weakened by loss of players through graduation and refusal of several of St. Leo's best players to participate due to differences with coach John Swart.
