## Faculty Lacks Confidence In Southard

Circulating throughout the various academic divisions Tuesday and Wednesday was a petition seeking an endorsement of confidence in the President of St. Leo College, Dr. Thomas B. Southard, by the teaching faculty.

The petition provides a numbered line for each of the college's sixty full time and nineteen parttime teaching faculty members upon which they may signify their "full confidence" in what the petition terms Southard's "moral, fiscal and academic leadership." The petition also

asks each faculty member to initial a statement that they have read the petition.

At press time the petition, after having circulated through the Divisions of Philosophy and Theology, Business Administration, Social Science and Language and Literature, had no signers. Approximately half the faculty had seen the petition. A faculty spokesman said the petition will be presented by Col. Edward McCabe, faculty association president, to Southard and copies will be made available to the board of trustees at their Friday meeting.

## Four Faculty Members File Sex Discrimination Complaint

Several St. Leo College female faculty members announced Monday their intentions to take action to resolve what they see as sexually discriminatory salary practices on the part of the college.

Physical Education professor Peg Hertz told the Independent Monarch that she was filing a complaint with the U.S. Department of Health Education and Welfare, under 1964 Civil Rights Act, Title VII. Assisting Hertz in her action is the National Organization of Women.

Asked what precipitated her actions Hertz said, "I felt I should be as highly paid as the others in my department. I have the education and experience the same as they (others in the department) do." Hertz is the only female full time instructor in the department.

"I talked with Norm (Norman Kaye, Chairman physical education) about the inequities in the department salaries, but he didn't agree. He told me to see the president (Dr. Thomas B. Southard, president St. Leo College). Hertz is

currently in her tenth year at St. Leo College.

The Independent Monarch also learned Monday that the other female professors intend to file complaints against the college on the same grounds, sex discrimination in salary practices. The three are Maura Snyder, Barbara Berger and Francis Martin. Snyder and Berger are with the Division of Language and Literature while Martin is in Social Science.

Martin told the Independent Monarch, "I'm only doing this for the people who work for the school in the future." Snyder added that she was also taking this action against the college because, "The common good necessitates this type of action for the future."

Both Martin and Snyder commented that they were prompted to file because of last week's Independent Monarch's article, "Does Sex Influence Salaries At St. Leo?"

## San Antonio Loses Two Pioneers


SAN ANTONIO — Part of pioneer Florida died here when Loretta Flannigan and C.P. McCabe were buried in the soil that gave them birth more than three-quarters of a century ago. Loretta was 75 when she died Oct. 15 and Connie was 76 when he died Oct. 18. The two were good friends all their lives and played together as children here in the streets of San Antonio.

Loretta leaves behind her brother, Eguene and sister, Mary. In the cemetery she has joined her mother and father, Kate and John, and her aunts, Mary and Sara Curley, and grandfather Curley. One of the main avenues here is named Curley Street in honor of the clan.

Loretta's father came from Rhode Island to Wildwood, as far as the tracks went, and then on to San Antonio by ox cart. He was a respected Judge here for many years. He was an enthusiastic promoter of this area and brought many settlers here. A graduate of Holy Name Academy, Loretta organized her own insurance agency, did income taxes, and

was city clerk. One of Loretta's most vivid memories was when, as a little girl, she watched workmen jack up Holy Name Convent in the center of San Antonio Park, put it on rollers, and haul it up the hill by oxen to the present location of Holy Name Priory. It was a major moving miracle in those days. Her mother Kate protested the action because, being a member of the San Antonio Garden Club, a number of her favorite trees had to be uprooted. As the convent inched its way up the hill, some of the Sisters stayed with it, eating their lunch along the way.

Con leaves behind his widow Effie; four daughters, Mrs. Nancy Burns, Mrs. Pat Reynolds, Mrs. Effie Sinora, Mrs. Eileen Diez; two sons, Cornelius B. McCabe, Richard McCabe; two sisters, Mrs. Mary Barthele, Mrs. Margaret DeHaven; 21 grandchildren and two great grandchildren. A prominent citrus man and civic leader, he served more than 21 years on the Pasco County School Board and was chairman of the board for almost 19 years.

## Trustees Meet Here Friday

The St. Leo College Board of Trustees will meet tomorrow at St. Leo. The meeting will get underway around 10 a.m. and continue until 3 p.m. While according to Joy Shepherd, director of public relations, the trustees agenda is not made public the board will discuss the nomination of new board members. The only other detail of the board's schedule available at press time was that there would be a luncheon for the board.

There were unofficial statements that Abbot Fr. Fidelis Dunlap O.S.B. would

present to the board of trustee copies of the petition that members of St. Leo Abbey and other religious persons connected with St. Leo College signed indicating that the college had been guilty of violations of moral principles laid down by Vatican Council II. The signers termed the violations "a sin." An attempt by the IM to confirm what, if anything, the Abbot would do at the board of trustees meeting was he was out of the country at press time. An Abbey spokesman did say that the Abbot would be back at St. Leo in time for the Friday board meeting.

# Look To The Future

This week the Board of Trustees are in town. It kind of reminds me of the 1972 Republican National Convention. Everyone knows what's going to happen.

The last time the Board of Trustees met they did such wonderful things as abolish the Encounter and Monarch and pass a resolution against murmuring on campus.

The Board is not meeting with some new problems on its hands. They discovered that they, and their money, were not the backbone of the Monarch (it still lives). They now have to face the problem of law suits coming from the (unjust) firing of Dr. Gmuer. They now have to face legal actions and law suits coming from female instructors who believe they are not paid fairly. They also have to face a faculty, who on the whole, are dissatisfied with the performance of the president of the college. But most important they are going to have to face students who are wondering if the Board really cares about the educational future of St. Leo.

When I first came to St. Leo I was told the school nick-name was the Monarchs. I didn't know they were referring to the role of the president at the time.

Many people in the community still have some faith in the Board of Trustees. It is believed that they are good Christian gentlemen and women and if they knew the truth behind the problems of the school they would act to save it. But the problems seem to be growing bigger and the inaction of the Board is frightening.

Are all members of the Board of Trustees against a free press? Do all members of the Board stand against unions? Do all members of the Board look at students as children? Do all members of the Board consider teachers only an insignificant part of this institution? Can any members of the Board speak to the faculty, staff or students; the president you have appointed will not for what he terms "legal reasons." This behavior is similar to that of Richard Nixon screaming "executive privilege" behind the pearly gates of San Clemente.

I ask the Board of Trustees to try to look past the recently cut grass and well kept shrubs to the real components of the College.

The students and faculty are the College. The administration exists to meet their needs for their benefit. Do not ask the administration how to solve the problems. Go to the students and faculty seeking their observations and opinions and go back to the administrators and TELL them how to better approach the resolution of St. Leo's problems!

If the president stays behind his door for too long he may come out one day to find an empty college with well kept grass. Will it take that?

## The Early Death Of Youth

Perhaps all the flower of the world's youth is getting killed off in the duties of the old who get more scared to die and have their sins finally catch up with them.

Everyone is concerned about the problem of aging. But what about the problem of neglected youth and the decreasing funds for public education of them; since World War II we, the arsenal of democracy, have reaped one hundred million dollars in arms sales to 236 nations on the earth.

Old folks fear death but youth welcomes it because the old folk's future on this planet has been lived while youths have no future.

Typical of the above premises is the operation of Saint Leo College under the Southard administration. There is no evidence of the colleges' academic progress in relation to attracting faculty scholars of repute, rather there is considerable evidence of its retrogression. Rather than upgrading the faculty and becoming known as a scholarly hall of learning, Saint Leo College has become known as an administrative boondoggle. Witness also in this issue the catastrophe the business office switch-play from Saint Leo Hall to Saint Francis Hall. Untold thousands of dollars were spent by Robert Richmond, vice president for Financial Affairs, under the aegis of his mentor, Southard, laying down new power lines

and switchboard; hiring of professional movers to haul the computers across the way to smaller quarters; hiring of a crane to move the safe; and the untold agony of all the women personnel moving from their former spacious place to the adapted, cramped, walled-in cells where they must now operate. There is something very much wrong when a college teaches courses in human relations and kicks the textbooks in the bonfire when it comes to practical applications of its own operations. And there is more in the office. . . admissions is switching to the former business complex, security is moving from old theatre building to admissions.

Witness also another administrative maneuver that resulted in the famous Southard lockout. After Brother Bernard voted, along with his community, to turn over the principal abbey buildings to the college corporation, he was evicted by Southard from his office where he was an integral officer who helped build the foundations of this college — under the pretext that it was needed by the former librarian, Don Schmoll, for book storage. After remaining empty for some time, the Monarch was moved in. Since the Monarch found disfavor with Southard, they were moved out. The office remains empty, locked and barred.

Tacit criticism of the faction to which I belong has prompted me to expose the reasons most of us believe as we do. I have every confidence that once our position is made perfectly clear it will be easier for the rest of the faculty to tolerate us.

To begin with, you can hardly expect most of us to sympathize with the aims, ethics, or moral positions you advocate. So many of us came into your world from planets eons away; our experience and orientation make it highly unlikely that we would share anything in common with you. In the areas from which we come, industry, business, the military, such concerns are non-existent or outright seditious. We were not brought up or educated in your world; we were conditioned and trained in another. To be perfectly frank with you, the liberal tradition of the American university system scares the hell out of us!

Secondly, while security and salary are of prime concern to you, you can scarcely expect that we would be concerned to the same degree. Our retirement plans and pensions make economic worries unnecessary. Our major concern is to pass the time agreeably.

Of course others of us operate from different motives altogether. We feel thankful that we have jobs at this college and don't want to lose them because the prospects are bleak indeed of finding others. Although we have talked bravely of academic independence, it is impossible to prattle long about professionalism when your credentials give you away. We are

simply unqualified to teach in a college or university, but glad Saint Leo hired us anyway — with no strings attached. To expect this kind of treatment from another college or university is absurd. Our experience with higher education in America is confined exclusively to this college and we prefer to keep it that way. Now surely you can understand this.

Then, of course, there are the parochial among us who like incurious and well-domesticated dogs prefer to trot in old and familiar labyrinths and to mouth well-gnawed bones. When one's entire existence has been spent doing exactly what one has been told to do and thinking exactly what one has been told to think, he is powerless to do anything else. What he wants most is to remain inert, untroubled by a spark of challenge or disturbed by the novelty of an idea. He is about as innovative as a conditioned reflex and sweats profusely at the thought of change. The past itself, and there is little likelihood that he will — or can — alter his position at this point. Expecting such people to assert themselves now is really not very realistic of you.

To be brief, these are the true and unvarnished reasons for our feeling as we do. We sincerely hope that you will consider them carefully and frankly admit the justice in the positions outlined. Unquestionably you will continue to disagree with us, but at least you will know us for what we are; you will understand us better.

# Save New York City




Postscript: And please, Lord, send us a golden calf. At the current market value of gold it would be a very heaven on earth.



Another drive will be held in February. Phi Theta Chi urges more people to participate in the next drive.




# Monarchs Play Rutgers

# Students Unite Against Racism

Over 1200 participants gathered in Boston, Massachusetts the weekend of October 10-12 to attend the second national conference of the National Student Coalition against Racism, held at Northeastern University. Formed in February out of a national conference of students at Boston University, NSCAR is a multi-racial youth organization seeking to unite students and all others involved in the struggle against racism today. The coalition launched its initial activities by mobilizing for a May 17 demonstration in Boston in support of school desegregation sponsored by the NAACP. Furthering school desegregation through the demand for the implementation of school busing has been and remains the central part of NSCAR's activities.

The slogan of the Boston conference was "Keep the buses rolling", with the current focal point of conference work being the ongoing struggle against racist forces in Boston and elsewhere who seek to undermine court-ordered desegregation of the schools through terror and violence, having so far failed to do so by legal means.

At the conference's opening rally Friday night, fifteen prominent speakers declared their support for NSCAR activities and outlined specific areas in the fight against racism. These included: Joseph Madison, president of the Detroit NAACP; Arturo Rivera, a leader of the Federation of Puerto Rican Socialist University Students; Gary Kampel, vice president of the National Student Association; Alice Cummings, an official representative of the National Education Association; Luis Fuentes, former superintendent of New York City School District One; Karen Galloway and Jerry Paul, attorneys for the Joanne Little defense case.

The conference also received endorsement from members of Congress: Ronald Dellums, Walter Fauntroy, Charles Rangel, Bella Abzug; Gary, Indianan Mayor Richard Hatcher, Karen Decrow, president of the National Organization for Women; Julian Bond and William Kuntzler.

A rousing speech was delivered by Denise Nicholson, one of four black students at South Boston High School who spoke at the rally about conditions in the school. She recounted on a firsthand basis the harassment of black students by state troopers and school officials, racist taunting and provocation by white students, and the racially discriminatory policies prevailing in the school. In reference to black demands for justice, Nicholson said: "We're not asking favors of those people. We just want them to treat us equal."

On Saturday, Oct. 11, the morning and afternoon were devoted over to workshops consisting of conference participants who formed resolutions to be proposed for adoption by the conference centering around the general areas of desegregation and busing, the fight against school cutbacks, and methods to be used in combatting racist frame-ups. These were followed by a general plenary session

Saturday evening, during which proposals were voted on and adopted, with additional workshops Sunday morning, Oct. 12, and the closing plenary session that afternoon.

Both the workshops and plenary sessions were democratically conducted, with the rules for procedure adopted by the conference stating that "the conference recognizes and respects the right of every speaker recognized by the chair freely to address the assembly . . . All questions before the conference shall be decided by simple majority vote." Volunteer marshals were organized to "maintain the peaceful and orderly character of the conference," and free access was granted to the media.

The main proposal on school desegregation was presented by the national coordinators of NSCAR, headed by Maceo Dixon, and adopted at the Saturday plenary session. It begins by pointing out the fact that busing to achieve school desegregation is being strongly resisted by a national campaign led by President Ford and a number of Congressional leaders which will inevitably result, if successful, in undermining the political, social, and economic gains that have been won by racial and national minorities during the past two decades of struggle against racism. The proposal reaffirmed the original stand taken at the founding conference of NSCAR in full support for busing to achieve desegregation and announced the initiation of a national campaign to defend school desegregation against all forms of opposition.

The resolution explained why busing was in the interests of black students and why it deserves full support, stating that blacks "are demanding to go to where better schools exist which happen to be predominantly white. Busing is a means to get better education not available in the all-black schools." It made clear that busing was not an attempt to force whites into having to attend inferior schools but rather was a means of pressuring local school boards into improving the schools so that all students, black and white, may receive the best possible education.

Stress was also placed on support for the right of oppressed minorities to community control of their schools and it was carefully pointed out that the demand for busing in no way undercut the demand for community control. "The fight for the right of students of oppressed nationalities to attend any school they want via busing is bound up with the fight of the same students to attend schools controlled by their own communities. Racist forces oppose both. To be fully effective in opposing the bigots, we must take them on at each front, championing both busing and community control." It was further stated that NSCAR fully supports the rights of non-black minorities — Chinese, Puerto Rican, Chicano, and Native American — to community control, equal education, and bilingual, bicultural education programs. In regard to the question of busing interfering with these demands the resolution said: "NSCAR activists should be crystal clear that any busing plan which cuts across the rights of other minorities must be amplified to uphold the rights of all oppressed minorities."

In a realistic assessment of the tasks ahead, the fact that a majority today are

opposed to busing was frankly admitted. To combat confusion over the issues surrounding busing and win the majority over to its support the resolution called for a nationwide "educational and action campaign to win mass support to school desegregation. We must win the majority of the American people to an understanding that busing is necessary to implement school desegregation."

In concrete form it was proposed that nationally coordinated activities be sponsored all over the county on November 22 in support for school desegregation and to fight against racism. Activities involving student and community groups of blacks, Chicanos, Asian-American, and other oppressed nationalities, as well as all student, political, and social organizations involved in the struggle against racism, are to be planned. These will take the form of forums, teach-ins, picket lines, demonstrations, rallies and other actions defending school desegregation. This proposal of the national coordinators, outlining the above, received the overwhelming approval of the plenary session - and its actions are to be fully implemented by the coalition.

In addition to the main resolution of busing and school desegregation, support was given to proposals dealing with the struggles against educational cutbacks which have a racist character, and the waging of vigorous defense campaigns for the victims of racist frame-ups. These are the other two vital areas of work for NSCAR.

NSCAR activists on campuses have pointed out that cutbacks on scholarships,

special admissions programs, and ethnic studies in conjunction with the raising of tuition, housing and textbook costs are aimed chiefly at black and Latin students. As Gary Kampel of the NSA put it: "We are well on our way back to the twenties when only white males had the key to the ivy-covered walls of higher education." A resolution was adopted calling for campus activities November 10-15 aimed against cutbacks which would further enlist support from other victims of budget cuts, such as welfare recipients.

Representatives of defense campaign committees for Philip Allen, J.B. Johnson, Delbert Tibbs, and Hurricane Carter, all victims of patently false frame-up charges from the government, addressed the conference along with a spokesperson from the Committee for the Freedom of the Puerto Rican Nationalist Prisoners. NSCAR is and will continue to be a main builder in these various defense campaigns.

With the conclusion of the conference on Sunday afternoon, the participants left the assembly in a spirit of full solidarity and with a firm sense of commitment to building and expanding the coalition. Dedicated to implementing the main resolution's call to action, the participants in the second of what will no doubt prove to be an ongoing series of such gatherings, went back to their local areas of work with the call of "On to November 22!"
