September has rolled around, and with it, the kick-off of another academic year at Saint Leo College. Amidst all the unavoidable confusion of the first week of school, it appears that the students, faculty, and administration have succeeded in striking the gong that gets the ball rolling.

Based on figures obtained from the Department of Public Information, Saint Leo College has retained its standard enrollment of more than 1,200 students. Broken down into specific categories, this figure includes 758 resident men, 277 resident women and 185 day students.

Of the total enrollment, 543 are new students composed of 383 resident men, 120 resident women and 40 commuters. These include freshmen for the vast majority with the remainder being transfer students from other colleges and universities.

All new students participated in an orientation program prepared by the Department of Student Affairs for the purpose of familiarizing the newcomer

to the particulars of Saint Leo College. The bulk of the program was held on Monday, Tuesday, and Wednesday of this week, but the schedule calls for it to be carried on through to the end of November.

Although the majority of students arrived this week, many students, faculty members, administrators, staff members and personnel have been steadily working in preparation for the inevitable onslaught of the student body. Of special mention is the Student Government Association, the floor directors, and the orientation leaders whose combined efforts helped to make for a smooth opening of the new school year.

The whistle has sounded and play has resumed. The action is about to begin. But, it must begin with the students. The president of the student body has referred to Saint Leo College as "The People's Place . . . where each of us has a responsibility both personal and social." Indeed, the year is young and the prospects bright.

An Introduction . . .

Our New President

The appointment of Rev. Marion Bowman, O.S.B. to the position of Acting President of the College has been of general knowledge for some time now. Of the various administration changes, this appointment is by all means the most important and the one which will most affect the students of Saint Leo College. Realizing this fact, *The Lion* has already taken the initiative to meet with Father Marion and has discussed with him certain questions that are of general interest to the student body.

Of major concern is the reason behind the resignation of Dr. Anthony Zaitz and the appointment of Father Marion. As the facts were presented to *The Lion*, Dr. Zaitz resigned for "personal reasons." His resignation was not formally accepted by the Board of Trustees until after the conclusion of the previous academic year. The reason for this was to prevent the transfer of the Office of the President from occurring in the midst of the academic year, thereby avoiding any controversy while school was in session. As to the appointment of Father Marion, the Board of Trustees chose him to function as "Acting President" while they continue to perform a thorough job in searching for a permanent president. Father Marion was selected to fill the vacancy on the

basis of his previous relationship with the College. He is among the original trustees and was instrumental in the actual formation of Saint Leo College.

When asked if his appointment was made in an effort to better the relations between the College and the Benedictine Abbey of Saint Leo, he answered emphatically that it was not. In his opinion, the two corporations already co-exist in a cooperative manner and there is no apparent problem at all concerning this matter.

In regards to the large degree of administrative turnover, Father Marion believes it to be beneficial in every way. Each administrator's job description has been stated more precisely and the administrators themselves are more competent in their newly appointed areas. They have become specialized in a specific area and consequently will be more able to key-in on the real issues.

As to the relationship between SGA and the Administration, our new president feels it to have come a long way and hopes it continues to prosper. He explained the process as one of "maturing . . . for the betterment of management and service."

When presented with the question of what he would most like to accomplish during his term as Acting President, Father Marion had a twofold answer.

The first is practical and deals with a very relevant problem—financial stability. The College as it stands now is at a touch-and-go point. Either it can continue to develop along the rapid pace it has set, or it can pace off and analyze its situation, thereby determining its financial responsibilities.

His second answer to the question, however, is the one he emphasized most. And that pertains to "the people side" of Saint Leo College, more specifically, the students. He described the learning experience as being a consolidation of all college living. His major concern is to bring the learning situation into student life and not just solely in the classroom. By doing so, students, administrators, and faculty will be unified in their efforts of creating a genuine source of school spirit and motivation. With a little personal effort, all Saint Leo students can make college life both "fun and exciting" and make themselves proud of their Alma Mater.

Just how Father Marion will function as Acting President cannot be determined at this point. But, provided he follows through on his admirable ideals, there is no reason not to be optimistic about the immediate future of Saint Leo College.

Official Statement of Policy

The 1970-1971 student handbook refers to *The Lion* as the official campus newspaper of Saint Leo College. It describes it to be "a forum of opinion as well as a medium of information of the collegiate community." In other words, *The Lion* exists to serve the collegiate community, more specifically, the students.

It is likewise assumed that the students themselves realize the purpose for which the campus paper exists and consequently utilize it for the fulfillment of that purpose.

It is the firm conviction of this year's newspaper staff that a campus newspaper is vital to the intellectual growth of the campus. One should be able to pick up a copy of a campus newspaper and come to a fairly accurate conclusion as to the over-all academic, social, and philosophic atmosphere pervading the institution.

Whether or not *The Lion* has in the past attained these ideals is irrelevant. In the opinion of some there was never a respectable campus newspaper at Saint Leo College. This is not aimed to judge our predecessors, but more, to serve as a source of motivation through which we might achieve these ideals. The campus newspaper is what we, the students, make it to be. It may for the most part be produced by a handful of students, but without the student body it is nothing. Not only should it be produced by the students, but also, geared toward students, and perhaps most of all, accepted by the students. This is not to imply that every student is expected to agree with the paper, but that the paper will be presented in such a way so that the students look forward to each succeeding issue. It will be considered a great accomplishment if this year's newspaper staff can succeed in producing a paper that will not only be read, but will also instigate constructive and mature response. It is hoped that many students will respond — either by submitting articles, taking action on ideas presented or by simply beginning to realize just what a college community is.

Speaking practically, *The Lion* is relatively restricted compared to other campus newspapers. This restriction is due largely to limited finances. But this is not to say that we cannot produce quality. Although *The Lion* will be produced on a bi-weekly basis, the newspaper staff promises to make those issues worthwhile, provided the students make it worthwhile. You will make it worthwhile by contributing to *Your* paper — either through submission of articles, ideas or simply a word of encouragement or constructive criticism.

Speaking as editor, I am obligated "to provide forum for all." This is your right. Use it.

It Can Work

CAMBRIDGE, MASS.—(I.P.) — The following resolution on Rights and Responsibilities, prepared by the student-faculty Committee of Fifteen, after broad discussion, has been adopted by Harvard's Faculty of Arts and Sciences:

Resolution on Rights and Responsibilities: The central functions of an academic community are learning, teaching, research and scholarship. By accepting membership in the University, an individual joins a community ideally characterized by free expression, free inquiry, intellectual honesty, respect for the dignity of others, and openness to constructive change.

The rights and responsibilities exercised within the community must be compatible with these qualities. The rights of members of the University are not fundamentally different from those of other members of society. The University, however, has a special autonomy and reasoned dissent plays a particularly vital influence in its existence.

All members of the University have the right to press for action on matters of concern by any appropriate means. The University must affirm, assure and protect the rights of its members to organize and join political associations, convene and conduct public meetings, publicly demonstrate and picket in orderly fashion, advocate, and publicize opinion by print, sign, and voice.

The University places special emphasis, as well, upon certain values which are essential to its nature as an academic community. Among these are freedom of speech and academic freedom, freedom from personal force and violence, and freedom of movement.

Interference with any of these freedoms must be regarded as a serious violation of the personal rights upon which the community is based. Furthermore, although the administrative processes and activities of the University cannot be ends in themselves, such functions are vital to the orderly pursuit of the work of all members of the University.

Therefore, interference with members of the University in performance of their normal duties and activities must be regarded as unacceptable obstruction of the essential processes of the University. Theft or wilful destruction of the property of the University or its members must also be considered an unacceptable violation of the rights of individuals or of the community as a whole.

Moreover, it is the responsibility of all members of the academic community to maintain an atmosphere in which violation of rights are unlikely to occur and to develop processes by which these rights are fully assured.

In particular, it is the responsibility of officers of administration and instruction to be alert to the needs of the University community; to give full and fair hearing to reasoned expressions of grievances; and to respond promptly and in good faith to such expressions and to widely-expressed needs for change.

In making decisions which concern the community as a whole or any part of the community, officers are expected to consult with those affected by the decisions. Failures to meet these responsibilities may be profoundly damaging to the life of the University. Therefore, the University community has the right to establish orderly procedures consistent with imperatives of academic freedom to assess the policies and assure the responsibility of those whose decisions affect the life of the University. No violation of the rights of members of the University, nor any failure to meet

Vehicle Registration Costs Skyrocket

... for students, that is.

Most students were shocked to learn that vehicle registration costs were to rise 750% this year. Vehicles, including "bicycles, motorcycles, and automobiles" are being assessed a fifteen dollar registration fee instead of the two dollar fee collected last year.

In a recent interview, Safety and Security Director, Charles Gordon, explained the rate increase as follows: the Brown Fund, established by Trustee Brown for the building and maintenance of roads, parking lots and general landscaping is completely depleted. This fund, under the direct control of Rev. Marion Bowman, now Acting President of the College, must be replenished so that roads can be maintained.

It was the decision of the Dean of Student Affairs that brought about the present rate increase, although the Safety Office had only recommended a three dollar increase to five dollars.

Apparently, this plan was conceived in haste as so many others recently. For it took no consideration of the different classes of vehicles and students in setting the rates.

The inequities in the system itself are immense. Why are day students, who must have a vehicle to get to and from school, charged as much as a resident student to whom a car is a convenience, not a necessity? Why are students, who must scrape and save as it is to get a college education, assessed three times more than the faculty who are salaried? Why are the members of the abbey and priory who use the roads all year long charged nothing while students, who at maximum, use the roads for three quarters of the year, are charged \$15.00? Why are bicycles and motorcycles charged the same as automobiles although the college makes no special accommodations available for the owners of these vehicles? There are many questions yet to be answered.

In a recent informal interview with Sister Lucy Faciane, Dean of Student Affairs, she admitted that she hadn't really had time to think about what she was going to do with the revenue from this vehicle registration fee. *The Lion* thinks that it is high time to think about these issues and hopes that administrators will be able to give more detailed answers concerning these problems in the near future.

Administration Changes

Saint Leo College administrative appointments and realignments were announced on May 12, 1970, by the Rev. Marion Bowman, O.S.B., Acting President of the College.

Dr. Robert H. Peterson, chairman of the Division of Natural Science and Mathematics since 1968, has been named Vice President for Academic Affairs and assumed the duties of the office on July 1. He succeeds Dr. Leo R. Downey who resigned last February.

Sister Lucy Faciane, O.S.B., moved from the position held for the past two years as Director of Women to Dean of Student Affairs, succeeding Norman D. Kaye who will devote full time to the development of the College's programs of physical education and intercollegiate sports as Director of Athletics and Head Basketball Coach.

Dr. Peterson is a graduate of St. John's University and North Dakota State

University and earned the doctorate in organic chemistry at the University of Utah. He was professor of chemistry at NDSU prior to his coming to Saint Leo.

Sister Lucy is a graduate of Barry College and holds the M.A. degree in administration and supervision from the University of Florida. She was principal of St. Anthony's School, San Antonio, during 1963-67 and is Mayor and former councilwoman of the Town of Saint Leo.

Mr. Kaye holds the B.S. and M.S. degrees from Northern Illinois University. He came to Saint Leo in 1966 as Director of Athletics and the following year became Dean of Student Affairs and Director of Financial Aid.

Administration of the College's financial aid program has been assumed by Peter L. Little, Director of Placement, in the Office of Development and Public Relations.

Experience Is Being

Sometimes the greatest amount of learning is gotten through an individual's initiative to break away from books and see what real-life experience is like. During the past summer, the assistant editor and editor of *The Lion* had the tremendous fortune of taking a two-month cross-county trip through this beautiful nation that took them over 14,000 miles. During the course of this trip, they kept a day-by-day record of each of their experiences which many times proved to be most unique. Following is but one of many experiences they encountered on their adventuresome journey.

* * *

—June 22, 1970; Monday:

... Having taken the subway to Greenwich Village, we spent the remainder of the evening sitting among the local hippies, students, drunks and park-goers at Washington Square. We managed to find a place to sit on a concrete wall that encircled the main focal point of the park. Two long-haired males with back packs and sleeping bags walked across the square, amusingly reminding us of our trip that lay ahead. The setting was peaceful. Rich men, poor men, white and black, young and old, sat around tables playing chess and cards. Waiting for their opponent to complete his move, some would slyly and seemingly unconsciously grab for a bottle hidden under cover of a brown bag. Although New York City has a population of close to nine million, we couldn't help thinking how lonely many of its people actually are. To think of all these strangers walking across the field of our watchful eyes and to think that each one, regardless of his social status, had his own story to tell, only made us wonder more. But amazingly enough, two did stop to tell their own stories.

The first one we called "Napoleon". We gave him that name because he wore a hat that looked like the one Napoleon lost at Waterloo. His appearance was anything but neat. He wore an untidy beard, a bleach-green teshirt, a dirty pair of blue jeans and a worn-out pair of sandals. Over his hooked-nose rested a lens-less pair of bent-up eyeglasses. He made his acquaintance as many a New York stranger does by asking for a cigarette. John obliged and a conversation ensued. His name really wasn't Napoleon, but Rusty. He had left his home in Laurenceville, Georgia, two months ago and came to New York to settle with the hip set. When asked whether he had left a family behind, he responded that he had left a so-called "plain family", but had now found a "real family". He proceeded to tell us that although he was 21 years of age, he had been married, divorced, and had a baby girl which he no longer cared for. Right now, all he was concerned about was his "chick", staying out of Vietnam, getting his quota of heroin, and staying alive. He talked of developing a protest movement in New York City where he thought there was a great need for youth rebellion. When we asked him how he supported himself, his answer was "chick, lead, and bread." And when asked where he lived, he answered simply, "anywhere." As we left him, he shook our hands and referred to each of us as his "brother".

The second acquaintance was the "Candy Man". We dubbed him that title because during the course of the conversation he offered each of us a candy orange slice. Like many of the others, he had migrated to New York, in his case, from San Francisco. He claimed to have spent three years in Woodstock, N.Y., working as an apprentice in art, and more specifically, in carving picture frames. He told us to be on the lookout for *Berkeley Mescaline*. As he put it, "It's really great stuff. It comes in three grades. The third grade stuff will get you high, but the first makes you second to a saint." He went on to say that he had nothing to do with heroin or other hard drugs, but was satisfied with only "mind-expanding hallucinogens." Using an excuse, he said, "Sorry, gotta go. Gotta pay my rent." As he walked away, John shouted, "Just for the books, what's your name?" He quickly replied, "Charles Donovan."

Benedictine Boys Village

Under the sponsorship of the Saint Leo Abbey Community, The Benedictine Boy's Village, a pre-delinquent and dependent boy facility has recently been opened.

The idea of the half-way house was conceived by Brother James, O.S.B. On July 6, 1970 the home was officially opened.

The former Counseling Center, across from Carmel Hall, has been transformed into living quarters for six boys, plus office and sleeping quarters for the manager and a small lounge area for recreation.

This pilot project in the pre-delinquent field will provide a home away from home for youngsters experiencing difficulties in adjusting to their present environment, as well as an opportunity to become competent in facing reality.

Counseling therapy will be provided under the direction of Dr. Flemming and by the college staff. Beginning this semester, the program will also serve for in-training for psychology students.

The boys of the Benedictine Boys Village come from various backgrounds but the main reason why they are delinquent is due to a lack of classroom environment. Brother James went on to explain that they have failed to make friends, have fun, and most of all win the respect of others in responsible ways. When a child starts thinking of himself as a failure and therefore not worth very much, he begins to choose to act irresponsibly and to strike back at others including his parents.

As the program is set up, a boy could be at the half-way house anywhere from a few weeks up to a year or more. It all depends on the individual person.

In regards to coming school years the six boys have been placed in either St. Anthony's Grammar School, Pasco High School, or Vocational Schools.


A well rounded program includes a wide variety of sports and recreational activities, all of which are available on campus and in the immediate area.

Abbot Fidelis Formally Installed

The Mass of the Abbatial Blessing of Abbot Fidelis J. Dunlap, O.S.B., fourth abbot of Saint Leo Abbey, took place Thursday, August 27, at 4 p.m. in the William P. McDonald Center of Saint Leo College.

Archbishop Luigi Raimondi, D.D., the Vatican's Apostolic Delegate to the United States, was the main celebrant of the Mass. Among the concelebrants were Florida's five Catholic bishops: the Most Rev. Coleman J. Carroll, D.D., Archbishop of Miami; the Most Rev. Charles B. McLaughlin, D.D., Bishop of St. Petersburg; the Most Rev. Paul F. Tanner, D.D., Bishop of St. Augustine; the Most Rev. William D. Borders, D.D., Bishop of Orlando; and the Most Rev. John J. Fitzpatrick, Auxiliary to the Archbishop of Miami.

Among the 52 concelebrants who participated, along with members of the Saint Leo Benedictine community in celebration of the event, were ranking representatives of the dioceses of Atlanta, New Orleans, Raleigh and Nassau. A dozen abbots from abbeys throughout the nation also added to the impressiveness of the occasion. The homily was delivered by the Most Rev. Thomas J. McDonough, D.D., Archbishop of Louisville.

Invitations to attend were sent to various clergymen of other faiths, as well as Catholic, throughout the Southeast. Other guests included representatives of government and organizations from the region, state and surrounding area.

Following the Mass of the Abbatial Blessing, guests enjoyed a wonderfully prepared buffet in the lower level of the McDonald Center. Participants in the concelebrated Mass along with the family of the Abbot and special friends enjoyed a splendid cocktail hour and dinner served in Marmion Cafeteria.

Abbot Fidelis, elected on June 12, 1970, succeeds the Rev. Marion Bowman, O.S.B., now Acting President of Saint Leo College. The new abbot has relinquished his position as a vice president of the College as well as director of library services. By virtue of his new office, he automatically becomes a member of the College's Board of Trustees.

Abbot Fidelis is a native of Pittsburgh and a graduate of Saint Vincent College and the Catholic University of America. Since 1951 he has become progressively active in the administrative affairs of both the Abbey and the College.

Father Leo R. Schlosser, O.S.B., admissions counselor of Saint Leo College, has been appointed Prior of Saint Leo Abbey according to an announcement of appointments and

elections made on July 1, 1970 by Abbot Fidelis.

Other appointments made by Abbot Fidelis in consultation with members of the Abbey community include the following: Father Thomas J. McCarthy, O.S.B., Subprior; Brother Jerome Reimer, O.S.B., business manager; Brother Joachim Svetlosky, O.S.B., secretary; and Father Andrew Metzger, O.S.B., member of the Senior Council.

Other members of the Abbey elected to serve as members of the Council are Father Damian Duquesnay, O.S.B., Father Robert Fuchek, O.S.B., Father Ernest Schultz, O.S.B., Brother Patrick Creamer, O.S.B., and Brother George Montpetit, O.S.B.

Prior Schlosser has been a member of the Abbey community for the past 17 years, 11 of which followed his ordination as priest on May 20, 1959. He will continue his association with the Saint Leo College Admissions Office but on a

limited basis, devoting a portion of his time as admissions counselor working with the public and private secondary schools in Florida.

Rev. Schlosser as Prior is responsible for the Liturgy as practiced at the Abbey, assumes the duties of Guest Master for the monastery, and takes administrative charge in the absence of the Abbot.

In 1962 Father Leo established St. Therese Catholic Church of the Byzantine Rite in St. Petersburg. Later he was priest in charge of St. Mary's Church in Masaryktown. He also served the Abbey as Subprior and Master of Ceremonies. Rev. Schlosser is the only priest in Florida who enjoys bi-ritual faculties, the special privileges granted by the Holy Father, Pope of Rome, through the Congregation for the Eastern Church. For the past year he also served as Auxiliary Chaplain at MacDill Air Force Base.

Director of Student Organizations Appointed

Amidst the almost complete overhaul of administrators taken place over the summer months, a totally new position has been created. Father Henry Riffle, O.S.B., newly ordained priest, has been appointed Director of Student Organizations on campus.

The formation of this position is due mostly to the student body who previously petitioned the Administration for such a capacity. Upon the approval of the Board of Trustees, the Office of the Director of Student Organizations was created so as "to assist student organizations to function in a fuller capacity of college life."

In a recent interview, Father Henry described the specifics of his office. In the past, the only real functional relationship between the students and the administration was through the Student Government Association. Since a large portion of the student body is orientated to the smaller organizations (fraternities, sororities, and clubs), there was no real means of communication with the Administration as an individual or a member of a relatively small group united in ideals. By the making of the administrative office of the Director of Student Organizations, such a means of communication has been established.

By the nature of his position, Father Henry assumes responsibility in seeing that this relationship is realized. This is not to say that he will function as a moderator or an overseer, but more as an administrative service to the campus organizations.

He made the point of stating that although SGA is a student organization, its relationship with his office will be considered in a special manner. Just what that manner is has yet to be formally stated. His immediate responsibility, however, is to the Panhellenic Council, the Inter-Fraternity Council and the Inter-Club Council. Although he will relate to these centralized organizations, he hopes to focus most of his energies on the individual fraternities, sororities and clubs.

Father Henry sees the situation of campus clubs as in need of the most assistance. Except for one or two, most of the clubs have not had any real organization and consequently are not functioning within the college atmosphere in the manner in which they might. As to fraternities and sororities, he hopes to strengthen them and to assist those potentially qualified on the long road of becoming national.

GRADUATION 1970

Saint Leo College granted a total of 244 baccalaureate and associate degrees to members of the Class of 1970. Commencement and Baccalaureate were held April 26 in the new Marion Bowman Activities Center.

Commencement speaker, D. Burke Kibler, III, chairman of the Florida Board of Regents, told the graduates, "There are enough volatile influences within the United States and throughout the world to disintegrate society in the '70's. Whether or not they prevail," he suggested, "depends largely on (the counter influence of) those young people of your age and education starting life anew in commencement exercises all over the U.S."

The Most Rev. William Borders, Bishop of Orlando, celebrated the Baccalaureate Mass. He invited the graduates to unite "with men and women working together in union with Christ, forming a community that can work toward the potential of man."





responsibilities, should be interpreted as justifying any violation of the rights of members of the University.

All members of the community—students and officers alike—should uphold the rights and responsibilities expressed in this Resolution if the University is to be characterized by mutual respect and trust.

An Interpretation of the Resolution on Rights and Responsibilities, proposed by the Faculty Council, was adopted by voice vote. It reads:

Resolved: that the Faculty regards it as implicit in the language of the Resolution on Rights and Responsibilities that intense personal harassment of such a character as to amount to grave disrespect for the dignity of others be regarded as an unacceptable violation of the personal rights on which the University is based.


Security Chief Announces New Student Advisory Board

Mr. Charles A. Gordon, Director of Safety and Security for Saint Leo College, today announced plans for creation of a student advisory board to his office.

Gordon, also Chief of Police for the Town of Saint Leo and a deputy sheriff in Pasco County, said that the purpose of this board would be to advise him of the students' positions concerning matters involving safety and security. In specific, this board would offer student opinion on the policies and procedures utilized by the Security Office.

At the same time, Chief Gordon said that he was proposing to the Dean of Student Affairs that a Drug Counseling Center, independent of his Office, be set up so as to provide information and guidance to college students. He emphasized the fact that this center would be independent and a place where a student could go for help without fear of prosecution.

The full-time campus security force, vastly improved since Gordon became director last year, currently numbers eight members. Also operating as an auxiliary unit is the Saint Leo Rescue Squad, a student organization which provides emergency assistance to the student body.
